POLICIES

Please read these policies carefully and sign at the end.

- **Spring 2013 and Summer 2013:** Spring classes being January 7th and end May 25th, 2013. Summer Classes meet June-August. (Fall classes will begin in September.) There are no lessons the week of Spring break, Thanksgiving, and the 2 weeks of Winter break. All other holidays (labor day, good Friday, etc.) will have regularly scheduled lessons.
- **Attendance:** You are able to make-up a class for illness, etc., by attending one of our other classes. Class times and days subject to enrollment. Please contact staff@velocitymusicacademy.com to schedule a make-up class. There are no refunds or credits for missed classes.
- **Pick-up and drop-off:** No one is available to watch your children before and after class. Please supervise children in the waiting room.
- **Registration fees:** A non-refundable enrollment fee of \$35 will be charged to all new students.
- **Tuition and Payment:** Tuition for the first child is \$55 per month, and \$27.50 for each additional sibling. Children under the age of 9 months attend free with a paying sibling. If paying by check or cash, please leave the check in the "tuition box" at Velocity Music Academy. Tuition is due by the 1st of the month and considered late by the 7th of the month. Payments made after the 7th will result in a \$25 late fee.
- **Discontinuing Lessons:** If you wish to withdraw from classes, written (e-mail) notice must be given by the 15th of the month to discontinue classes for the next month. A student may be dismissed for nonpayment of tuition.
- **Class Policies:** Please, no food or drink in the classroom. Rhymes, Rhythms & Songs classes are an informal, movement related approach to early childhood music education. Some children will sit and listen quietly, and some will move around the room. Don't be worried if your child doesn't appear focused! Each child is learning in his or her own way. However, for the safety of your own child and other children, please redirect your child if they begin running in the classroom. Initial _____
